How your data is collected.

Interactions by phone, messaging, post, and email including personal data you provide when,

- Booking our guest accommodation
- Requesting documents to be sent to you.
- When you provide us with feedback
- When you contact us in the ways outlined above.
- By CCTV footage externally during your stay

Data we receive about you from third parties.

We receive data from third parties as outlined below,

- Technical data from analytics providers and search engine providers
- Financial and transactional data from payments services
- Data from third party booking platforms.

How your data is used

- To carry out contractual obligations entered between you and us, including, where requested, any third-party services you wish us to make available to you during your stay.
- To carry out feedback, supply direct marketing offers in relation to future stays, conduct research on our services and develop business strategies.
- To comply with the law if approached and found that we have a legal obligation to provide your data. e.g., in a criminal investigation

How we secure your data

We use technical measures to secure your data at a level appropriate to the risk of processing your personal information, i.e., the use of firewall and encryption software on our in-house servers.

 We use organizational and governance measures to protect the information stored appropriate to the risks associated with processing your personal information, i.e., minimizing access to data, staff training and policy revie. We will notify you as soon as we become aware of any breach in data security.

Your Rights to your Data
